## MONDAY NIGHT RINK RENTAL POLICIES AND PROCEDURES

**CAPACITY:** The Boston Common Frog Pond Skating Rink can hold up to approximately 450 skaters. Music will be played for the duration of the event.

**RINK CHARGE:** The cost of renting the rink is \$575 for one hour and a half or \$1,150 for three hours. This charge is for ice time only.

**FINANCIAL ARRANGEMENTS:** Payment in full is required to reserve a rental date. No date will be held without payment. Payment for other charges is due at the close of the event by cash, check, or credit card. Payment for ice time is NON-REFUNDABLE, except in the event that the skating rink is closed by the rink manager due to inclement weather or other unforeseeable causes.

**CANCELLATION:** (Weather and Non-weather Related Conditions) The Skating Rink operations may be impacted by inclement weather or by unforeseen circumstances. If an event is in question, call 617-635-2120. If it becomes necessary to cancel an event, it will be canceled 3 hours before the event on that day. If an event is canceled, the event organizer will receive a FULL refund of their deposit or may rebook the event on another mutually agreeable date.

**ALCOHOL:** No alcoholic beverages are allowed in the Boston Common.

**SKATE RENTALS, SNACK BAR, AND OTHER CHARGES:** Skate rentals are available for an additional charge of \$5 per pair for children and \$8 per pair for adults. Lockers are available for \$1 per locker. The snack bar will remain open during all events. Outside vendors or personal catering is not allowed at the rink. The event organizer must decide PRIOR to the event if these charges are to be incurred by the guest or by the renting organization. SNACK BAR ITEMS MUST BE PAID BY SEPARATE PAYMENT DIRECTLY TO THE SNACK BAR BY CASH OR CHECK ONLY. ALL SNACK BAR SERVICES MUST BE PAID IN FULL BY THE CLOSE OF THE EVENT.

**PARKING:** Parking is available in the Boston Common Garage, located directly under the Boston Common with an entrance on Charles Street between Boylston and Beacon Streets. Parking fee information is available from the garage and is the responsibility of the guest.

**LIABILITY:** Guests skate at their own risk. I understand that recreational and other activities involve inherent risks of INJURY and DEATH. I will notify my guests of these risks and all guests will voluntarily agree to expressly assume all risk of injury and death that may result from participation in recreational activities, which relate in any way to the use of this facility, or from any other activity at this Skating Rink.

**CONDUCT:** To insure the safety and enjoyment of our guests and clients, no unsafe or disruptive behavior will be tolerated on the premises. Intoxicated patrons will not be permitted on the ice. No hockey sticks or other equipment are allowed on the ice. The Boston Common Frog Pond Skating Rink has the responsibility and the authority to exclude events inappropriate for the facility.

The coupons will be counted at the close of the event to determine the final charges.
